### Professional Standards and Ethics Committee

The purpose of the Professional Standards and Ethics Committee is to define the standards of professional responsibility for certified health physicists (CHPs) and to review all complaints about ethical practice that are referred to this committee by the Executive Committee. During the past year there have been no complaints about CHPs acting unethically that have been forwarded to this committee for evaluation. This suggests that our colleagues are continuing to conduct themselves in a professional and ethical manner.

Another responsibility of the Professional Standards and Ethics Committee is to select the Joyce P. Davis Memorial Award winners. The Davis Award is given in memory of Joyce P. Davis, in recognition of her dedication to the advancement of health physics and her humanitarian efforts to uphold the ethics of the profession. The recipients of this award demonstrate the extraordinary qualities exemplified by Joyce P. Davis by distinguishing themselves for excellence in professional achievement as well as being admired for ethical behavior and interpersonal skills.

This year the Professional Standards and Ethics Committee *did not receive a single nomination for the Joyce P. Davis Award*. Surely there are many deserving candidates for this award. The committee respectfully requests that all CHPs take a moment to consider the work of their colleagues and consider nominating those who are deserving of this award. A call for nominations will appear again in the December issue of *Health Physics News*—it is never too early to start preparing a nomination.

### AAHP Committee Appointments

In the first half of the president-elect’s term, the paramount responsibility is identifying and recommending committee chairs and new committee members for those rotating off committees at the end of the year. This process begins after the Health Physics Society (HPS) midyear meeting and concludes prior to the annual meeting of the HPS. This timing is important because the incoming chairs and new committee members need to be approved by the American Academy of Health Physics (AAHP) Executive Committee at its meeting (which is held in connection with the HPS annual meeting). For the AAHP, the terms of office run on a calendar-year basis, so those selected have about six months after their selections to prepare.

Each current committee chair was contacted, and those whose terms will expire were asked to recommend someone to succeed them as committee chair for 2016. Remaining committee chairs were asked whether they would like to continue as the chair for 2016.

New committee appointments were made to replace members whose terms are expiring. These appointments were based on a list of the people who had volunteered (on their dues statements) to serve on AAHP committees.

The American Board of Health Physics (ABHP) held its summer meeting on 11 July 2015 in Indianapolis, Indiana. The board members (with term expiration dates in parentheses) for calendar year 2016 are:

One of the primary missions of the board is the preparation, administration, and grading of the certification examination each year. The task can be accomplished only because of the dedicated work of Part I and Part II Exam Panel members and their respective chairs and vice chairs: Paul Jones (2015 Part I Panel chair), Chris Martel (2015 Part I Panel vice chair), Richard Adams (2015 Part II Panel chair), and Wei-Hsung Wang (2015 Part II Panel vice chair). I would like to acknowledge their contributions and express my sincere gratitude for their hard work. I would also like to thank all board members for their part in reviewing exam questions.

One aspect of exam preparation is the “wise-person” review of Part II of the exam. The process is fairly straightforward: the ABHP chair solicits three volunteer certified health physicists (CHPs) as wise persons to review a draft of the Part II exam. The review covers a wide spectrum to ensure that the domains of practice are fairly represented, the premise of the question is clear, the question is unambiguous, grammar and spelling are correct, references are up to date, units are consistent, and the question includes all expected information that would be needed to answer the question. The board expresses its sincere gratitude to the 2015 wise-person panel: Kent Lambert, Govind Rao, Jerry Hiatt, and George Chabot (alternate).

The ABHP certification exams (Parts I and II) were offered on 13 July in Indianapolis, Indiana, and at 18 other sites. Of the 347 total applicants (334 in 2014), 48 candidates in Indianapolis took the Part I exam and 28 candidates took the Part II exam (candidate numbers at the other sites were not available at the time of this report). I want to personally thank all the CHPs who volunteered their time to proctor the exams. Without their support, it would not have been possible to host the exams at other locations.

Also, I want to offer a very special thanks to Executive Secretary and Program Director Nancy Johnson for her leadership and unwavering support in organizing all exam-related activities.

Working on the exam panels is a rich and rewarding experience. In addition to the benefits of networking with experienced CHPs and exchanging ideas on current topics, it also awards a very generous portion of the continuing education credits needed for recertification. I strongly urge all CHPs, if they have not already done so, to seriously consider volunteering to serve on an exam panel.
