Minutes

The meeting was called to order by President Gordon Tannahill at 8:03 PM. Introductions were made. Minutes of the Spring 2013 Executive Council meeting were distributed by Gordon and reviewed by those in attendance. John Bauhs made a motion to accept the minutes. Shari Mask seconded the motion. The minutes were approved unanimously.

The Secretary/Treasurer's report prepared by David Paulu was distributed by Gordon. The report was reviewed and is attached to these minutes. In accordance with the Chapter Bylaws the Executive Council determined that the Chapter's financial health does not warrant any increase to the membership dues. A motion was made by John Bauhs and seconded by Gary Yarrow to keep the dues for 2014 the same as in 2013. The motion was approved unanimously.

Shari distributed the Affiliate Report prepared by Chris Kessler. The report was reviewed and a comment made that Gary Beardman is no longer with Landauer. A copy of the Affiliate Report is attached to these minutes.

Mike Lewandowski reviewed his report on the website, radiation instrument kit, science teacher grant and science teacher meetings and workshops which was previously submitted to the Executive Council. A copy of the report is attached. Mike recommended the Council consider

attending a science teacher meeting in Minnesota and/or Iowa in 2014 to increase awareness of Chapter resources, including the science teacher grant. (Note: The LAC report was presented under Other Business.)

Gordon indicated that the Chapter had received applications from two new members. They will be announced at the Business Meeting.

Gordon welcomed the incoming Chapter officers who were present at the Council meeting: Glenn Sturchio, President-elect, Mike Lewandowski, Secretary/Treasurer and Victor Goretsky, Councilor. Gordon agreed to chair the Nominations Committee to select candidates for the next Chapter election. The Bylaws indicate that the Nominations Committee should include a total of 5 members, none of which can be sitting officers of the Chapter. The Bylaws also stipulate that the slate of candidates needs to be submitted to the Executive Council no later than 60 days prior to the Spring Meeting. Gordon will ask for volunteers for the Nominations Committee during the Business Meeting.

The agenda for the fall meeting was reviewed. Shari Mask agreed to write up the summary of the technical meeting and submit it to the HP News. Mike and possibly Gen Roessler will be taking photos for Shari to use in the article.

Mike indicated that he had submitted an application for AAHP credit for both the spring and fall meetings and was waiting to hear back from the AAHP.

Gordon indicated that the spring meeting will be held on 11 April 2014 at Assisi Heights in Rochester, MN, as a joint meeting with the AAPM chapter. Glenn described the conference facility and the plans to have a joint plenary session with the AAPM followed by separate sessions, breaks and lunches so that the costs associated with the meeting can be separately managed by each group. Victor volunteered to host a meeting in Madison for spring 2015.

Mike discussed the preliminary financial outcome of the Chapter's involvement as the host of the HPS Annual Meeting in Madison. A more detailed report will be presented at the Chapter Business Meeting. Preliminary calculations indicate that the Chapter stands to receive about \$5,000 in net income for hosting the annual meeting. The Council had previously agreed to provide the profit from sale of the logo merchandise (shirts and hats) to the Lakeshore Technical College Student Branch in return for their efforts in selling the items. The profit amounted to about \$830 from sales during the meeting and another \$35 from post-meeting sales. A motion was made by Gary Yarrow, seconded by John Bauhs, to round the amount up to \$1,000. The motion passed unanimously.

President Tannahill adjourned the meeting at 8:40 PM.
