The North Central Chapter of the Health Physics Society (NCCCHPS) held its spring 2012 meeting Friday, 27 April, at Brookings, South Dakota. The meeting was held on the campus of South Dakota State University (SDSU) with a technical program, a business meeting, exhibits by vendors, and a technical tour.

The technical program was organized by chapter President-elect Gordon Tannahill. Richard Vetter, chapter member, HPS past president, and HPS congressional and agency liaison, spoke on “Biology vs. Epidemiology: The Need for an Integrated Model of Radiation Risk.” Jeffrey Brunette, Mayo Clinic Rochester, discussed some of the personnel dose issues associated with the increasing use of positron emission tomography (PET) imaging procedures, the successes and failures in reducing dose with the adoption of automated dispensing systems for PET agents, and some of the problems encountered in adopting automated dispensing systems. The third speaker was Adam Hoppe from the Department of Chemistry and Biochemistry at SDSU, who spoke on how imaging tools familiar to medical physics have a variety of applications in biochemistry and biophysics.

Chapter President Robert McTaggart, associate professor of physics at SDSU, conducted the chapter business meeting.

The chapter’s radiation instrumentation kit is in regular use. During the 2011–2012 school year, it was used three times by two different high schools in Minnesota, a middle school in Wisconsin, and the South Dakota teachers’ meeting.


